

# Water Loss Management Training

# September 5, October 10, and November 7

#### **Course Description:**

Nationwide, an estimated **six billion gallons per day** of water is taken from water resources and never reaches the customer; this is enough water to supply the drinking water needs of the ten largest cities in the United States. Many community drinking water systems in PA deliver water to customers through aging distribution systems; withdrawing, treating, and supplying water for which they **may not be fully receiving revenue**. To help water utilities in western PA address this growing issue, SPC and PADEP are partnering to present a **three-part instructional training series** on water loss management for water operators, water managers, water authority personnel, engineers, and water system board members.
